
Rally Site: "South Jetty" on Humboldt Bay



ULTRA COACH CLUB ARCHIVE REPORT 02/90 by Norm Helmkay #547

As you likely read on the last page of the 1989 Winter Newsletter, our archives are under way with the help of the few who have provided their old newsletters and other "Ultra" memorabilia.

While the response has not been overwhelming we are making progress and I still have "a grain of mustard seed" hope that more of you will "move that mountain" of old paper that I know is out there somewhere.

Between now and the spring rally in Florida is the right time to send the "good stuff", as the cost of mailing is much less than if you wait and send it to me in Canada later. Its also a great winter file clean out project. Our Florida address until April 7, 1990 is:

Re-publishing all the old tech-tips in booklet form is an archive project spin-off we are working on from the old newsletters.

One of the difficulties of identifying loose pages we have received is the older newsletters were often undated and have no page numbers. It is almost impossible to identify when they were published unless there happens to be a references to a known rally mentioned in the text. I'm glad to see the pages of recent newsletters are well marked.

I'm happy to tell you we have all the newsletters from February 1971 to April 1977, largely as a result of being able to photo copy all of the notes left by Ed Martin which are in the custody of Ernie Newhouse.

We have received no newsletters prior to February 1971, nor any with dates after April '77 up to the fall of 1982. From 1983 to date, the following newsletters are missing: Winter 83, Spring 86 and 87, Fall 86 and 87. If you have any of the above, please send them along.

Packets of Ultra memorabilia from Gus Brining and Pat Fitzgerald are almost beyond belief. Its like Christmas with every envelope I open. All the old factory and owners letters, the announcements of new models and options, etc.

NOTES FROM DAYS PAST..... In January 1971, a rally at the Lion Country Safari near Laguna Beach had 66 coaches with 146 people.

Did you know in the March 1973 newsletter, a 127 point Ultra Van Safety Check list was announced and by June, 75 members had asked for copies. At a rally in Tecopa Hot Springs, the list was used by Mech Mechem, Len Ryerson and Ed Martin to inspect 10 of the 27 coaches that attended. Ed mentions in the June newsletter, "...without wishing to alarm you, we found things on every van that needed attention." I wonder, now 17 years later, how our coaches would stack-up against the list. If you want a copy of the 4 page list, send \$1 to cover copying and postage.

ULTRA POSTSCRIPTS ****

"What lies behind us AND what lies before us are tiny matters COMPARED to what lies within us." - Ralph Waldo Emerson

RESOLUTIONS: Now that the New Year is well on its way, maybe a few of us are "working" on resolutions we made as the clock struck twelve and 1990 was born. One of our New Year's promises was to practice a little more passiveness and HUMILITY. Also attempt to be a better husband, a better club member, and a better citizen of this great nation. Plustry a bit harder to see the BEST in everyone. For example: Scores of members do so many good things for Ultra Club. I'm sorry for being lax in expressing appreciation to people who seem to be always "in there" helping the club to thrive and succeed. Guess it's human nature to simply ACCEPT the fine efforts of other humans without offering proper gratitude. We should say "THANK YOU" when a good deed is noted. I'm going to try to be better at that during 1990.

The great wise man, Confucius, wrote, "MUD slung is always GROUND lost."

NIGHTIME SECURITY: Most motorhome owners sometimes park overnight near a 24-hour restaurant, on hospital grounds, at roadside rests, supermarket parking areas, and so on, when enroute to a destination. For added safety some RV experts advise a police-type siren or "whoofer" be roof-mounted, with switch to activate it by your bed inside. If there are homes nearby, this affords much protection. Just ask our good members, Al and Martha Hoffman (Wolf Point, Montana) about their harrowing experience while parked overnight in front of a friend's house some years ago. At night, in case of ruffians or vandals, the loud, piercing siren would alert nearby homeowners, security officers, or local police or business personell, probably to call for assistance if needed. The shrieking alarm, alone, will deter most having destructive intent. If you are being disturbed, you have the right to "crow" loudly. Almost anyone can quickly install such a pulsing-sound horn on a motorhome roof with 12-volt lead run up from the clothes closet. If the device is well grounded, a single hot-lead through a hole drilled in the roof will activate it. Seal the hole with mastic. Think about this little safety idea if you occasionally park overnight in semi-risky areas.

In America the average cost to pull a tooth runs about \$10. In China it costs \$320. People say, "That's awful." Yes, but it's an AWFUL job for the Dentist, too, when you can't open your mouth.

HYPERGLYCEMIA ZOMBIES: It is estimated that there are at least FOUR MILLION persons in the United States who are walking around with the illness "hyperglycemia" WHO DO NOT KNOW THEY HAVE IT. It can be very crippling if left un-cured---but it is EASILY treated if recognized early enough. Everyone must be cautioned against excessive drinking of sweet pops, and eating too much dessert, sugar or candy which may lead to the pancreas-organ breakdown. This short discussion is meant to be helpful; no one wants to learn of any club member needlessly losing his or her eyesight, going into a coma, or requiring a limb amputated. Often the need for insulin injections can now be solved with a simple prescription pill named "Tolazamide" or its generic. Common symtoms of the disease include: blurry vision, increased thirst, a wound that heals slowly. Hyperglycemia IS DIABETES. Unless we know the exact indicators (one or all, or others), you (or I) could be one of that vast million-zombies walking around NOT KNOWING we are VULNERABLE to the serious consequences. Doctors urge everyone to get a blood test at least once per year. Pancreas failure can strike at ANY AGE --- a 14 year old neighbor boy has it and requires daily insulin injections.

Bob Stevens of "Motorhome Life" and your humble executive director, together with a few other ULTRA CLUB members, have long noted that cats, dogs, even canaries, take "on" the characteristics of their masters. We do NOT mean to imply that this is necessarily evil; it may be an acquired GAIN. But it is a fact of life. Often husbands become the image of thir wives, and vice versa, while animals take on the likeness of their respective masters. Now---who wants to look LIKE a poodle? Maybe a hound dog? Not a word of the above (nor any sketch) applies to OUR club membership. So there:



THE GOLDEN RULE: There are TWO valid meanings (one cryptic) of the "Golden Rule", ie: (#1) "Those who EARNED the gold are entitled to rule." and (#2) "Do unto others as YOU would have others do unto you."

NO CHRISTMAS: Did you and I have a right to be born? We are not taking sides, but all of us need to think long and hard before answering such a question. Today there is much controversy regarding "rights". Many arguments are raised - pro and con. Debate rages as to a mother's rights. The father? Does the child have any rights? Let us pique our thinking on the total subject---CONSIDER: What would the WORLD be like without Christmas? Would it be different if Mary had sought an abortion? Would the earth be even more pagan? 
The main purpose of this, of course, is to provide the membership with the most accurate and useful information possible.

TECHNICAL TIPS

<u>Ultra Technical Tip #1-90</u>: California Smog Inspections. Ref: Ultra Manual, Section 17, page 17-22.

The following information is a quote from the Dec. '89 issue of "Cars & Parts" magazine: "New California smog check extends back to 1966 models. Changes in the California "Smog Check" law, effective earlier this year have affected owners of vehicles that previously had been exempt from the xeow-yearly mandatory inspections. Previously, vehicles 21 years old or older had been exempt. Now, however vehicles made in model year 1966 (passenger cars and light trucks up to 8,500 pounds gross vehicle weight) need smog checks.

The reason for this change is that although the number of 1966-74 vehicles registered in California are relatively small, their emission levels may be as much as 10 times higher than the levels from vehicles manufactured since 1980.

Only 1965 and older vehicles will be exempted on the basis of age, but 1955-65 vehicles may still need inspection on transfer of registration or initial registration in California." (End quote)

Check your license renewal slip to see if it contains a check off block for a vehicle weight over 8,500 pounds, or verify that your vehicle meets the requirements of the California Highway Patrol, Handbook Sheet #82.1 as shown in the Ultra manual as referenced above.

<u>Ultra Technical Tip #3-90</u>: New Replacement V/8 Engines. Ref. Ultra Manual Section 14, page 14-2.

Looking for a replacement engine for your Ultra V/8? Your local GM (Chev.) dealer has the following three engines available at this time.

The first two are the standard engines 350 and 305 C.I., which are priced at \$1,280 and \$1,235. They come minus the carb, alternator, and exhaust manifolds. These prices are already discounted assuming that you know someone in the automotive field that will buy it for you.

In case you want the Ultra to really move out, you should consider the third engine, which is called the "350~C.I./345~HP High Output Engine". It is identified as Chevrolet Part

number 10134338. Other than the great horsepower you get out of this engine, the other benefit is that it is 250 pounds lighter than your present Ultra V/8. (It has aluminum heads and intake manifold.)

The specifications are too numerous to note here, so please refer to the March 1989 issue of Hot Rod magazine. See page 62. Back issues can be attained by calling their office at (213) 854-2470.

Engines come minus carb, exhaust manifolds, distributor, spark plug wiring and alternator. It would require different carb (4 BBL), exhaust manifolds or headers and distributor. Price: List \$3,200 or discount priced at \$2,700 through your local repair shop.


In assembling this Newsletter, it came out with an extra page; rather than leave it blank, I will try to explain what goes into our Newsletter.
