

### Last newsletter we asked for thoughts and prayers for Larry Forman and here is his response

Hi Everyone,

I just wanted to send a quick note how appreciative I am for all the positive thoughts and prayers for my recent recovery from what started as food poisoning.

Rosie and I attended the 2019 International Met Convention in Castle Rock, CO. We left Sacramento on June 14th caravanning with another Met owner who was also flat towing his Met behind his RV as we did behind our Ultravan. We had a great time and left on Sunday, June 23rd, stopping in Salt Lake City to do some research of my family history. We stopped in Reno on June 28th planning to do some hotel checking for a possible 2021 Met Convention in Reno the next day. We had dinner at the Grand Sierra Resort while we camped in their RV park.

I contracted food poisoning from that dinner but felt just well enough to drive to Sacramento until I again felt bad enough to go to the emergency room at Sutter General. I was transferred to the hospital a day or so later while they continued testing me. I was then transferred to the ICU when my blood pressure dropped and my liver panel went through the roof. They called Rosie and said I was "gravely ill" when I could not remember my name or where I was (a first for me). After spending six days lying in bed at Sutter General, I was released after noon on July 4th. Later I read my discharge papers where they said I had "extreme sepsis" and pneumonia. Either of which could have killed me.

I am extremely glad to have now about fully recovered and am thankful for all the wonderful concerns and prayers and cards/notes I received. It is extremely humbling to come through something like this. I am now back to working on the Ultravan with plans to continue working on Rosie's Met and back to my normal routines. Live well,

# BY LARRY FORMAN

I received this recipe this morning and it looked good so I made it for dinner tonight. It is SUPER easy and I made just a few changes. Since we had bags of four chicken thighs each that were browned, frozen, and sealed for possible travel and other uses, I used one of those bags. The browned



thighs are bone-in, so I had to pull the bones out after about 7 hours of slow cooking. I had to also be sure that I removed any knuckles along with the bones. The texture of the pulled chicken was much better than chopped chicken. We only had mild chilies, so it could have used a bit of "heat" (since it had none), but even with that, Rosie said it was really good.

We used our 3 gt. Instant Pot Mini on low temp slow cook, and the recipe filled it nearly 3/4 full or a bit After several hours cooking, we drained about 1/3 to 1/2 of the liquid to use as soup for I would have cut down the chicken stock by about half to keep it from being excessively soupy. I did not add any salt since I was concerned that the chicken stock might already have plenty of salt in it. We did not have a lime or avocado for the topping but it was still very good.

You certainly could use raw chicken thighs as per the recipe, but I suspect that browning them and leaving the bone in might have added some flavor.

I will definitely make this again, but will likely try either medium or hot chilies next time.

Highly recommended and Chungah, owner of <a href="https://damndelicious.net">https://damndelicious.net</a> seems to live up to her web site's name. This would be an ideal dinner recipe for slow cooling at an RV park or while on the road if you have an inverter at around 750 watts or more.

## STINKY RVZ

#### SUBMITTED BY ROSIE WALKER

What can you do to ensure that your vintage trailer doesn't get that funky musty smell? Mold and mildew can make your trailer stink and do damage to the soft surfaces inside your RV. The musty smell when you walk into the RV is an indication that there are damp areas where mold could be growing. A dehumidifier in your RV when it is stored for extended periods of time will prevent the build-up of moisture.

Mold can occur during winter as windows are closed and the surface of walls and windows become colder because the outside air temperature is lower. Simply opening a window is not a solution in the winter months, this is where a dehumidifier comes in. It will reduce the level of humidity in the air by sucking in air from the room at one end, removing the moisture, and then blowing dehumidified air back out into the room again.







Many RV owners find that compressor dehumidifiers would not work well at temperatures below 60 degrees Fahrenheit, and there were often problems with the compressor dehumidifier machines icing up. These dehumidifiers address these issues, functioning consistently well at all temperatures.

You can also attract and remove moisture from the air with a scented moisture absorber. For \$10-\$30 you can protect your vintage trailer from moisture damage while you eliminate musty odors. Excess moisture is absorbed into the white calcium chloride crystals. The white crystals begin to harden and form a solid mass. Hardened crystals must be discarded and re-purchased as they are used. Another trick is to place open containers of coffee (a cup or so) in your cabinets. The coffee grounds can help neutralize any odors that you may already have.



## Hutchinson, KS to have an Ultra Van permanently on display

The Reno County Museum in Hutchinson, KS, started looking for an Ultra Van for display over a year ago. Now, they have one. Ultra Van #393 was donated to the museum this summer. Below is the Press Release from the Museum.

#### FOR IMMEDIATE RELEASE:

Something big is coming to the Reno County Museum:

Through a donation, the Reno County Museum has gained the opportunity to accept an UltraVan into its collection. This particular UltraVan is in need of some restoration and preservation efforts. We are happy to announce that Collins Bus Corporation will lead those efforts

Why Collins? Well the Collins Bus Corporation's origin story begins with the UltraVan. "Since Don Collins, Sr., the founder of Collins Industries was integral in the early days of the UltraVan, it only made sense for Collins to again lead the charge," said Henry Platts Manager, Reno County Museum.

UltraVans were produced by Ultra Inc. at the Hutchinson Naval Air Station from 1966 to June 1970. "We are very excited to be part of the restoration process on this UltraVan, bringing it back up to its original look and feel," mentioned Chris Hiebert, Vice-President / General Manager of Collins Bus.

UltraVans are a unique type of class A motorhome. They are powered by a Corvair engine and transaxle. The UltraVan was designed in the early 1960s by aircraft designer David Peterson. The construction of the Ultra is very airplane-like, with boxed aluminum sections and fiberglass body extensions.

Since its beginning, the UltraVan has held customer loyalty even though it is no longer in production. This lead to the development of a nationwide UltraVan club which is still in existence with yearly rallies. In 2017, the Reno County Museum hosted one of these rallies.

We are inviting you to share in documenting its arrival. Which is expected to happen in the next couple of days. We look forward to coordinating this with you.
