

Thank you for your inquiry about GROUP ULTRA VAN. We are a Chapter of the CORVAIR SOCIETY OF AMERICA (CORSA). Our main interest is keeping ULTRA VANS running and on the road. This means that our organization is more technical than social. We publish a bulletin every quarter. Most of its contents is a supplement to Len Ryerson's ULTRA MANUAL. Since most of the ULTRA VANS were Corvair-powered (310 out of 360) CORSA was a logical affiliation. Most of the ULTRA VANS will wind up with collectors of this type. CORSA also has much information on V-8 powered Corvairs, so no ULTRA VAN enthusiast is left out.

Our Dues are \$18.00 a year (\$14.00 for CORSA, and \$4.00 for GROUP ULTRA VAN). To be a member of our Group, you must be a member of CORSA. They publish a 30-page full color magazine just packed with Corvair information, plus a listing of ULTRA VANS and parts for sale, which go out to 7,000 members each month. You will be able to use this classified section for FREE. Also available is a listing of every member (7,000) across the country. If you have a problem anywhere while traveling in Canada or the U.S.A. there is a member nearby.

We also use the CORSA "Communique" to list all of the ULTRA VAN rallies held across the country. This allows CORVAIR enthusiasts to get a closer look at our vehicles.
